1. Artwork must be square. Maximum size: 12"x12".
2. Any 2-D media is accepted.
3. No text should be included. (Text will be added later when CD is produced.)
4. Included label must be **firmly** attached to the back of the work.
5. Artwork must be original.
6. Design Contest open to Iowa students in grades 9-12.
7. Entries must arrive by 5:00 pm, December 22, 2020

9. One Winner and up to 10 Honorable Mention awards will be announced on or about January 14, 2022.
10. First Prize is \$100, and the winner's artwork will be used for the cover of the Corridor Jazz Project CD. Artwork may also be displayed in other areas to promote the project.
