



## 2026 CORRIDOR JAZZ PROJECT CD DESIGN GUIDELINES

1. Entries must be received by 5:00pm, December 19, 2025
2. Artwork must be square. Maximum size: 12"x12".
3. Any 2-D media is accepted.
4. Physical prints are required. If an accepted entry is created electronically, we will ask for the original digital file for maximum quality.
5. No text should be included. (Text will be added later when album is produced.)
6. Included label must be **firmly** attached to the back of the work.
7. Artwork must be original.
8. Design Contest open to Iowa students in grades 9-12.

10. One Winner and up to 10 Honorable Mention awards will be announced on or about January 12, 2026.
11. First Prize is \$100, and the winner's artwork will be used for the cover of the Corridor Jazz Project CD. Artwork may also be displayed in other areas to promote the project.
